As per the announcement of the Hon'ble Minister for Higher Education on the floor of the Assembly on 26-8-2021, Tamil Nadu State Council for Higher Education (TANSICHE) took various steps to prepare a new Model Syllabus for Under Graduate and Post Graduate courses in the Universities and Colleges.

On the request of TANSICHE, 777 syllabus copies of Under Graduate courses and 423 syllabus copies of Post Graduate courses were received from Universities and Autonomous Colleges.

Thereafter, TANSCHÉ formed 95 syllabus preparation committees, to prepare model syllabus for UG and PG courses. TANSCHÉ invited Senior Professors and Expert Members of Board of Studies in various subjects from Autonomous Colleges and Universities and conducted more than 425 Subject Experts Committee meetings.

The Experts were requested to take into consideration, the salient features of UGC Guidelines, CBCS, LOCF, the Hon'ble Chief Minister's Naan Mudhalvan Scheme, Skill Development Programme, Industrial Inputs, Internship in Industries, Entrepreneur concepts, Competitive Examinations, Employable Skill and Communication Skill Enhancement etc., in revamping the UG and PG syllabus for various courses.

The members of the Subjects Experts Committee have completed the preparation of new model syllabus for 127 (50 UG and 77 PG subjects). The High Level Committee constituted under the Chairmanship of Dr. H. Devaraj, Former Vice-Chairman, University Grants Commission, New Delhi approved the methodology of preparing the syllabus on various subjects.


Now the prepared Model Syllabus copies on various subjects are sent to you for your consideration and adoption as per your University Act with the following guidelines:

- Mandatory inclusion of 75% course content from model syllabus to preserve equivalence in UG and PG degree programmes to enable student mobility.
- Preferential inclusion of remaining 25% course content by individual institutions (Universities and Autonomous Colleges).

The Government have already announced that the new syllabus will come into force from the next academic year 2023-24. Therefore, you are requested to take appropriate steps for the realization of the Government's announcement.
