5.1.1. Policy Document for Scholarship

The State Government of Tamil Nadu has created a policy document to encourage students belonging to the socially backward sections of the society to pursue higher education and the details of the scholarships being offered are listed below.

1.	SC/ST Scholarship	Eligible for all students of SC/ST category – No income ceiling.	State Government of Tamil Nadu
2.	Backward class (BC) / Most Backward Class (MBC&DNC) Scholarship	Eligible for all students of BC/MBC/DNC category – No income ceiling.	State Government of Tamil Nadu
3.	First Graduate Scholarship	Annual income of the Parents should not exceed Rs.1,00,000/- (Family members should not be a graduate)	State Government of Tamil Nadu
4.	BC Minority Scholarship	Students belonging to Muslim / Christian religion - Annual income of the Parents should not exceed Rs.1,00,000/-	State Government of Tamil Nadu
5.	Pudhumaipenn Thittam (Moovalur Ramamirtham Ammaiyar) Scholarship	Girl students who studied in Tamil Medium from class 6 th to 12 th .	State Government of Tamil Nadu
6.	Incentive for Tamil Medium Students	Graduate students who are studying in Tamil Medium	State Government of Tamil Nadu
7.	Indira Gandhi Single Girl Child Scholarship	Post Graduate Students who are single girl child in their family.	Government of India
8.	Scholarship for Children of Farmers	Students who are children of Registered Members of Farmers Welfare Association.	State Government of Tamil Nadu
9.	Scholarship for Children of Construction Labours.	Students who are children of Registered Members of Construction Labours Welfare Association.	State Government of Tamil Nadu
10.	Scholarship for Children of Sewing Labours	Students who are children of Registered members of Sewing Members Welfare Association.	State Government of Tamil Nadu
